

NOTICE OF MEETING

HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 285

The Board of Directors of Harris County Municipal Utility District No. 285 will hold a regular meeting on **Monday, June 16, 2025, at 6:30 p.m.**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, **Suite 2400, in the San Jacinto Room**, Houston, Texas 77027, to discuss and, if appropriate, act upon the following items:

1. Hear statements from the public and receive written questions.
2. Minutes of prior meetings.
3. Review Arbitrage Rebate Report for the Series 2015 Refunding Bonds.
4. Discuss Association of Water Board Directors summer conference, approve reimbursement of eligible expenses, and authorize attendance at winter conference.
5. Discuss American Water Works Association conference and approve reimbursement of eligible expenses.
6. Financial and bookkeeping matters, including payment of the bills, review of investments, and amend budget for fiscal year end March 31, 2026.
7. Tax assessment and collections matters, including payment of tax bills, installment agreements, delinquent tax collections, sales tax reports, and requests for estimates of taxable value.
8. Adopt Resolution Nominating Candidate for Board of Director Election for Harris County Appraisal District.
9. District website matters, including emergency alert/messaging services.
10. Security services matters, including report from Harris County Sheriff's Office.
11. Development in the District.
12. North Channel Water Authority report.
13. Detention facilities report, including proposals and task orders for additional maintenance.
14. Garbage collection and recycling services, including report from Best Trash.
15. Engineer's report on construction projects in the District, including the following:
 - a. authorize design of facilities in the service area;
 - b. approve plans and specifications and authorize advertisement for bids for construction of facilities in the service area, including:
 - i. water, sewer and drainage facilities to serve New Forest Town Center West;
 - c. review bids and award contracts for construction of facilities in the service area, including:
 - i. water plant no. 1 drainage improvements; and
 - ii. generators for wastewater treatment plant no. 1 and lift station nos. 1, 3, 4, and 5;

- d. approve pay estimates, time extensions, change orders, certificates of completion and final acceptance for projects in the service area, including:
 - i. detention pond to serve tract located off Wallisville Road east of Carpenters Landing;
 - ii. lift station and storm water pump station to serve tract located off Wallisville Road east of Carpenters Landing; and
 - iii. waterline extension and force main to serve tract located off Wallisville Road east of Carpenters Landing;
 - e. review and approve report on electricity consumption and energy efficiency measures and take any necessary action;
 - f. deeds, easements, plats, surveys, as-built certifications, appraisals, phase I environmental assessments, consents to encroachment, and utility commitment requests, including:
 - i. out-of-District water and wastewater service for Harris County Precinct No. 1 maintenance facility;
 - g. development of geographic information system;
 - h. update on bond application no. 15; and
 - i. proposals for engineering services.
16. Harris County Fresh Water Supply District No. 51 water plant rehabilitation and upgrade project.
17. Operator's report, including:
- a. operation, maintenance, and repair of District water, sanitary sewer, and storm drainage facilities;
 - b. sanitary sewer manhole survey;
 - c. customer billing and collection;
 - d. smart meter installation program;
 - e. amendment of District Rate Order;
 - f. approve Consumer Confidence Report and authorize operator to mail Consumer Confidence Report and file certificate of mailing with the Texas Commission on Environmental Quality; and
 - g. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
18. Authorize execution of Interlocal Agreement with Harris-Galveston Subsidence District for Water Wise Program.
